

Eligibility and Entry Period

- **Promotion Period:** The PrimeWay \$500 Weekly Giveaway promotion begins on **January 5, 2026**, and ends on **April 4, 2026** ("Promotion Period").
- **Weekly Drawings:** One winner will be randomly selected each week of the Promotion Period. The first drawing will be held on or about the first week following the start date, and subsequent drawings will be held weekly thereafter.
- **Eligibility Requirements (Automatic Entry):** To be automatically entered into the weekly drawing, a PrimeWay member must meet the following criteria during the relevant weekly period:
 - Have a monthly direct deposit of at least **\$500** posted to their PrimeWay consumer account.
 - Perform at least **two (2)** debit card purchases per week, with each transaction valued at **\$10.00 or more**.
 - Meeting these requirements within a weekly period automatically grants one (1) entry into that week's drawing.
- **No Purchase Necessary/Alternate Method of Entry (AMOE):** Membership in the credit union is not required to enter and will not improve your chance of winning. Members and non-members who wish to participate in the promotion without meeting the direct deposit and debit card transaction requirements must submit a 3x5 card with **"PrimeWay \$500 Weekly Giveaway"** Promotion, their name, address, and phone number to P.O. Box 53088, Houston, TX 77052, Attn: Marketing Department or to any retail center location.
- **Entry Limit:** Only one (1) entry per person, per week, whether through automatic qualification or the Alternate Method of Entry (AMOE).
- **Disqualification:** Incomplete or illegible entries may be disqualified at PrimeWay Federal Credit Union's sole discretion. Entry forms become the property of PrimeWay Federal Credit Union and may be used for the purposes of marketing the credit union's products and services. Personal information will not be shared with unaffiliated third parties.

Prizes and Winner Notification

- **Prize:** One prize of **\$500** will be awarded each week, with an estimated retail value of \$500.00. The prize will be disbursed to the winner's account or by check. Prize may not be substituted with cash or another item.
- **Odds of Winning:** Odds of winning are based on the number of eligible entries received for that week's drawing.
- **Winner Notification and Claim Window:** The winner for each week is entitled to only one prize and will be notified by phone. The winner must claim their prize within **thirty (30) calendar days** of notification. If the winner cannot be contacted by phone or fails to claim their prize within the 30-day claim window, an alternate winner will be selected at random.
- **Age Requirement:** Must be 18 years or older to enter.
- **Employee Exclusion:** Volunteers and employees of PrimeWay Federal Credit Union are not eligible to enter.
